8. Treasurer's Remarks – Karen Ross

Karen presented a brief update on our finances to September 30, 2025.

Income

- Income is about 10% lower than expected for this time of year which is a little surprising; hoping our yearly pattern of donations continues and we see a greater income in the last part of the year

Expenses

Administration Account – close to expected; office rent is \$0 because we expense it through the Memorial & Honour restricted fund.

General Account – overall lower than planned, as usual; good to see our Social account is being used. Parent Church – payments have been made as planned.

Pastorate Account – a slight increase in Health & Benefits because the Mennonite Church has increased their benefits amount

Overall the deficit is higher than last year, and higher this time of year because historically people give more towards the end of the year - hoping the pattern of larger donations near year end continues.

Karen reminded us that there are tax credits when you donate to any charity – donations reduce your taxes. Thank you so much for your continuing generosity.
